# New York state vaccine counseling program coverage

Highmark Blue Cross Blue Shield of Western New York (Highmark BCBSWNY) partners with Amerigroup companies to administer certain services to Medicaid Managed Care (MMC) and Child Health Plus (CHPlus) members. Please note, this information is specific to the MMC and CHPlus programs only.

In partnership with New York state, Highmark BCBSWNY provides reimbursement for COVID-19 vaccination counseling for dates of service on or after December 1, 2021, to Medicaid, MMC, and CHPlus members to encourage the administration of the COVID-19 vaccine.

#### Reimbursement criteria

Providers may bill for COVID-19 vaccine counseling provided to Medicaid members:

- As a stand-alone service when all the criteria specified in this guidance are met and documented.
- In addition to an evaluation and management (E&M) or well-child visit when all the criteria of the vaccine counseling visit specified in this guidance are met and documented, in addition to all the necessary components of the E&M/well-child visit.
- Whether or not a COVID-19 vaccine is administered during the encounter.
- Using the Medicaid-enrolled child's client identification number (CIN) when counseling is provided to a
  parent, caregiver, or guardian for the benefit of the child, with or without the child present during the
  counseling session.
- For up to four counseling visits per vaccine dose recommended by the Centers for Disease Control and Prevention (CDC), when the member has not received and does not have an appointment to receive the recommended dose, up to a total of 12 visits per member per year.
